- Authored legislation to establish Root River Watershed Restoration initiative

- Advocated to restore Racine Water Patrol to 7 day, full week service
- Organized public events on Root River, combined efforts with REC Center and local yacht club
- Completed agreement for redevelopment plan in Root River corridor and brownfield areas
- Negotiated agreement to keep a major Midwest festival, Brewfest, in Racine
- Established survey and notification system for constituent communication
- Uncovered illegal storage and movement of hazardous medical waste
- Began initiative to create ordinance against bullying and intimidation; currently in draft stage
- Racine County Ambassador to state capitol
